What is Data Classification?

Data Classification is broadly defined as the process of organizing data by relevant categories so that it may be used and protected more efficiently. In business parlance, data classification is the process of categorizing all data present in an enterprise into groups, based on certain shared characteristics like sensitivity, value to the organization, etc.

Need for Data Classification

Data classification is one of the most important ingredients for enforcing data security within an organization. Whether you are a private, public or government sector organization, the very basic need of data security is to identify and classify data which enables organizations to select and deploy appropriate security controls based on data sensitivity, as per business requirements.



Dynamic Data Classification




- Enforce end users to classify MS Office documents on Save, Save As, Print and Close events

Quick Classification

Classify and/or re-classify MS Office documents, PDF documents, images and other file types with a simple right click. This feature does not require the user to open a file to apply classification.

- Right click on file(s) to apply Quick Classification
- Add visual markings and metadata without opening the file
- Automatic application of overlay icon on file(s) confirming classification action





Bulk File Classification

Classification empowers organizations to govern the distribution of their business critical data in conformity with standards and regulations. Klassify provides users the option to classify their retrospective data using Bulk File Classification, where they can classify multiple documents in one go.

- Classify multiple MS Office documents, PDF documents and other file types
- Select visual markings and positioning
- Classify password protected files by pre-specifying the password
- Insert metadata and capture logs
- Automated classification of files when copied/ downloaded in a Folder/Drive




Email Classification

Apply classification labels in subject and body of MS Outlook and Office 365 emails to clearly identify the sensitivity of the data information being shared. Klassify tags email metadata with selected classification which increases the effectiveness of DLP and Email Security solutions.

- Enforce email classification
- Enforce attachment classification
- Real time alerts in case user try to send higher classified attachment(s) by applying lower classification to email
- Add metadata to email header
- Define whitelisted/blacklisted domains, email ids to prevent data going to unauthorised users
